GETTING READY FOR THE TRIP

- Online Ticket Purchase
 - Indicate you use a wheelchair



- Fill out any information pertaining to traveling with a wheelchair provided by the airline
- Seat assignment
- Check in online, Call airline 24 hours before to confirm
- Hydration Concerns
- Edema- compression stockings
- Arrive a minimum of2 hours before domestic flight
- TSA- can go through security line-do not have to get out of chair.
- Identify needs to Ticket Agent
- aisle chair/assistance
- Baggage check
- · Checked baggage
- Carry-on
- Wheelchair to gate
- · Gate-check items- wheelchair protection

AIRPORT ASSISTANCE

- Have Transport Chairs to push through airport if needed
- Assist getting through TSA
- Provide Boarding Chairs to get into aircraft
- May assist with transfer to airline seat- depends on airline, airport, or transport company in each country

WHATS IN THE BAG

- Wheelchair Bag" -Duffle bag/carry-on
 - · Storage of items you need to remove from wheelchair



- · Cushion and support surfaces for aircraft seat
- Duct tape
- Wire ties
- Pneumatic tubes for tires if needed
- Plastic roll to wrap wheelchair
- Towel –standard bath size
- Labels with contact information (name, phone, address)
- Power Wheelchair:
 - Make a sign with instructions

BAGGAGE

- Anything medically related is not included in baggage count
- Shower Chair
- · Sports Chair
- Medications
- · Catheter/Bladder and Bowel management supplies
- Cushion and support devices for aircraft seat

TSA

- Wand or pat body and wheelchair
- They will ask if you can move forward so they can wand your back

CHANGING STATIONS

- Started in UK- Heathrow
- Several in Canada and Australia
- First one in USA 2017- now more than 25 at larger airports.

- Length of flight
 - Pressure Relief Technique
- Bladder Management
 - Mountain Dew
 - Blanket
 - Urine bag->gel
 - · Accessible bathroom



STOWAGE OF WHEELCHAIRS

ON COMMERCIAL AIRCRAFT

- Generally storage for one manual wheelchair in-cabin
- Cargo hold for most chairs (1)
- Some very compact designs may be allowed in-cabin beyond this (2)
- RGK

STOWAGE OF WHEELCHAIRS

CARGO HOLD

WHAT CAN GO WRONG?

- Untrained TSA staff
- Lack of assistance at airports
- Non-working boarding chairs
- Aircraft seat armrests do not flip up
- Dropped transfers
- · Inability to get to lavatory
- Unsupportive aircraft seats
- Lost or damaged wheelchair

INCIDENCE

- Estimate 744,00 flights with wheelchairs on USA commercial flights 2022. (DOT report)
- Estimate 835,327 flights with wheelchairs on USA commercial flights 2023. (DOT report)

INCIDENCE

UNITED STATES DOT AIR TRAVEL CONSUMER REPORT

FAA Reauthorization Act of 2018: Must report



- · All handled wheelchairs on all flights
- · All mishandled wheelchairs and scooters
- From January 1, 2019 and after, airlines must also report this data for their branded codeshare partners.
- Department of Transportation publishes yearly results each February
- 2023 Statistics
 - 11,527 wheelchairs mishandled
 - .38/100
- Down from 2022
 - 1.41/100

Federal Aviation Administration Reauthorization Act 2018

- Study on the feasibility of flying in a wheelchair
- Mishandled wheelchair data
- ACAA Federal Advisory Committee
- Bill of right for passengers with disabilities

US: ACAA Advisory Committee

Established 2019





- Recommended standards and improvements to airline checklists and forms for handling wheelchairs to increase consistency across airlines
- Air Transportation Association consistently apply the Special Service Request Codes.
- Creation of Passenger Accessibility Advisory Group

US: Government Accountability Office GAO

November 2022 Report to Congress addressed:

Barriers to accessible air travel

Sensory and physical assistance

TSA checks

Ticketing

Handling and stowage of devices

Onboard assistance and lavatories

- Steps airlines have taken to reduce those barriers
- DOT has progressed response to and enforcement of FAA Reauthorization Act of 2018
- Recommended Passenger Accessibility Advisory Groups, now taken up by all major US airlines
